## **School Policy for Pupil Premium**

# Act, Believe, Succeed

## April 2022

At Saxilby Church of England Primary School we believe that all our children have an equal entitlement, and should have an equal opportunity to:

- Develop imagination and creativity
- Acquire skills and abilities
- Have a love of learning

The school receives funding from the Government to support it in trying to meet this aspiration. This is known as the Pupil Premium.

Pupil premium is additional funding, from the government, provided to schools for supporting more pupils from low income families to ensure they benefit from the same opportunities as all other children.

There are three categories in all that qualify for pupil premium:

- ✓ Those registered for free school meals (FSM) plus those who have claimed FSM at any point in the last six years (known as 'Ever 6 FSM').
- ✓ Children Looked After (CLA) and Post-LAC. Children adopted from care under the Adoption and Children Act 2002 and children who have left care under a Special Guardianship or Residence Order.
- ✓ Those recorded as Service Child in Education (SCE) or Ever 4 Service Child (who have been a SCE within the last 4 years) or in receipt of a child pension from the Ministry of Defence.

All children who currently qualify for free school meals based on their family circumstances are entitled to pupil premium. This applies if you receive any of the following benefits:

- Universal credit (provided you have a net income of £7400 or less)
- Income support
- Income-based jobseekers' allowance
- Income-related employment and support allowance
- Support under Part IV of the Immigration and Asylum Act 1999
- The guaranteed element of state pension credit
- Child tax credit, provided that you are not also entitled to working tax credit and have an annual gross income of £16,190 or less

# **Principles**

- We ensure that teaching and learning opportunities meet the needs of all of the pupils
- We ensure that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed
- In making provision for socially disadvantaged pupils, we recognise that not all pupils who receive free school meals will be socially disadvantaged
- We also recognise that not all pupils who are socially disadvantaged are registered or qualify for free school
  meals. We reserve the right to allocate the Pupil Premium funding to support any pupil or groups of pupils the
  school has legitimately identified as being socially disadvantaged.
- Pupil premium funding will be allocated following a needs analysis which will identify priority classes, groups
  or individuals. Limited funding and resources means that not all children receiving free school meals will be in
  receipt of pupil premium interventions at one time

#### **Provision**

The range of provision the Governors may consider making for this group could include:

- Reducing class sizes thus improving opportunities for effective AfL and accelerating progress
- Providing small group work with an experienced teacher /TA focused on overcoming gaps in learning

- Pupil Premium Intervention to carry out provision and will monitor and evaluate provision across phases
- 1-1 support
- additional teaching and learning opportunities provided through learning mentors, trained TAs or external agencies
- Pastoral support on a 1 to 1 or small group basis
- Practical support to overcome barriers to accessing the school life to the full eg. school uniform support, emergency support
- Support with one off costs such as uniform, equipment, necessary educational visits and other educational requirements
- Once the deposit has been paid to secure the place, the costs of residential visits will be funded for children in receipt of FSM
- Children accessing Pupil Premium will be able to access one fully funded music tuition place. If there is nonattendance for 3 consecutive sessions or the teacher reports lack of positive engagement the lessons will cease.
- All our work through the pupil premium will be aimed at accelerating progress moving children to at least age related expectations and beyond. Initially this will be in communication, English and Maths.
- Pupil premium resources may also be used to target able children on FSM to achieve mastery with in their age related expectation
- All children who access pupil premium funding will have a Pupil Premium folder. Teachers will meet termly
  with the family to ensure the child's global needs are being met and every opportunity is taken to meet their
  needs.
- All children accessing Pupil premium will have a Pupil Premium folder and documented intervention
- Service children will access Tiger Stripes club with Family support worker on a regular basis.

#### Reporting

- It will be the responsibility of the Headteacher or a delegated member of staff, to produce regular reports for the Governors' on:
- the progress made towards narrowing the gap, by year group, for socially disadvantaged pupils
- an outline of the provision that was made since the last meeting
- Pupil Premium and Service children numbers
- an evaluation of the cost effectiveness, in terms of the progress made by the pupils receiving a particular provision, when compared with other forms of support
